

## Minister's Report | To Bless the Space Between Us

Dear friends of Knox-Metropolitan United Church;

I am trying really hard to begin this report with using the word 'unprecedented' and I'm also pledging to avoid the word 'pivot' from here on in...we'll see how well I do!

Early in the pandemic the title of one of my favourite books of blessings began resonating – from John O'Donahue (who you may have heard me refer to once or twice)...

#### To Bless the Space Between Us

2020 was an eventful year for the community of Knox-Metropolitan United Church even before the Board met on March 15 to make the difficult but necessary decision to cease all in-person activity and close the church building to all but the most limited staff activity.

January (remember January?) saw us grappling with challenging issues of Restorative Justice which drew us into conversation circles, to listen and hold one another's input with compassion. That month also saw the congregation accept a recommendation from the Board to begin a piece of work with McNair Business Developments on a Feasibility Study related to our *Being There When The Future Comes* future planning project (a project that would take unexpected turns come mid-March).

At the end of January and into the beginning of February, we held our final meetings about becoming an Affirming Ministry before voting to do so on February 9. Those final meetings called us into deep conversations, listening and wrestling with who we felt called to be and how we felt called to articulate this to the world. These meetings, including that on the 9<sup>th</sup> were not without their challenges, and while we celebrated a clear outcome in the affirmative, the journey towards the vote left many things for the community to unpack and work through together. We began to do so, once again gathering in circles, but this process is one of many things that COVID-19 derailed.

I write this letter a few days before the 14<sup>th</sup> when we will officially be declared an Affirming Ministry as part of our Sunday morning service – which is a truly exciting moment I look forward to sharing with you all.

And then the page on our calendars flipped and March arrived, and with is changes unlike what many of us have experienced before. Having watched the coronavirus spread through Europe, and especially places like Italy there was a great concern about what might occur here in those first weeks.

Volunteers began immediately calling folks within the congregation who lived alone or were otherwise vulnerable to check in. Our regular worshipping patters changed immediately and by March 22 (just one week after the last 'normal' service in the Sanctuary) we had begun a pattern of Knox-Met Kids @ Home in the morning and Vespers services in the evening. Wednesday mornings, the little ones of the congregation gathered to see each other on Zoom, to sing, hear stories and share their Apples, Onions, and Spicy Carrots (apologies to onion lovers) and in the evening others gathered to share prayers and engage in spiritual practices.

We'd initially hoped that It would all be done by Easter (a funny thought as we prepare for a second Easter of online worship) and joked that we'd not meant to give us **this** much for Lent.

Yet new opportunities arose, as former KMUC folks from the West Coast, the North and Ontario tuned in, and new people local to Regina and elsewhere became engaged in the life of the church despite having never stepped into the building physically. Weekly coffee gatherings on Zoom began both on Sundays (as our Traditional Service returned to it's regular 10:30am timeslot) and Thursdays, Board, Ministry and Committee Meetings as well as Thursday evening Theology groups, and webinars on Anti-Racism, (held in response to calls from Black Clergy and leaders within the Unite Church to work in predominantly white congregations) attended by folks around the province!

In a much lower-tech innovation, deliveries of groceries and grocery cards ensured that many within the community of KMUC who rely on services no longer available to them had nourishing food and knew the care of community.

As spring turned into summer and the province of Saskatchewan began to engage in a process of re-opening, Knox-Met did the same, I was privileged to work with the rest of the staff and the Re-Opening Committee (Elizabeth Calam, Joan Garden, Jim Garden, and Liz Ivanochko) who in addition to following the often-changing public health standards fmet weekly usually with many emails in between. Joan lays out the work of this group in great detail later in this report so I will simply express my thanks and ask others to do the same to this group!

This work allowed worship to become a hybrid with both in-person and online attendance throughout October and into November until rising cases and calls from medical professionals to support their work with increased caution saw us return to online only.

Amidst all of this the work of imagining the future continued, as the Being There When The Future Comes worked with McNair Business Development INC. to see the completion of the Feasibility Study and it's presentation to the Board, Administration, the Trustees and Finance Committee. There is much to consider in this document as we wonder what KMUC will look like in the future and whether lessons of this past year will help us know what is the right, next, faith-filled step.

One of my favourite moments in the year at KMUC (and I am not alone in this) is singing Silent Night by candlelight on Christmas Eve (I like it so much I generally do it 3 times on one night). It was strange to do so this year more than a week before the 24<sup>th</sup>, with only 6 people present in the Sanctuary wearing masks while filming – but there was still a beauty there.

That which is born of the Spirit comes with creativity and tenacity, within challenging moments when we have the humility to look for her persistent nudging. May we continue to be open to the song that she sings in and through each one of us...and may we continue to **Bless the Space Between Us.**

## Chair of the Board | Called to be The Church

It is an understatement to say this was an unusual year, and in spite of all that has happened following the spread of COVID-19, there have been many occasions for rejoicing.

We started with three important meetings.

A significant decision was made at a congregational meeting of February 9, 2020, when KMUC voted in favour of becoming an Affirming Ministry and join Affirm United/S'affirmer Ensemble. The official recognition of this milestone has been delayed until the celebration held on February 14, 2021.

The church continues to grow, aided by the receipt of 12 people into membership at the church service of Sunday, March 1, just before our Annual Congregation Meeting.

The third significant meeting was held on Sunday, March 15, 2020 when the Board met after church to make its first decision to discontinue in-person worship. For the next six months—with thanks to the planning of Cam Fraser and Hart Godden—worship services would be held on-line.

Throughout the months to follow, significant questions of whether and how to re-open the church for inperson worship were always present. In June, the Board approved the creation of a Safe Re-Open Plan for KMUC to prepare for in-person worship when the situation surrounding COVID-19 and Public Health orders would permit. A very dedicated team of volunteers considered all requirements with respect to social distancing, population numbers, special equipment, traffic flow, how to register participants and all other aspects necessary to implement the Provincial Health Guidelines and recommendations from Living Skies Regional Council.

In addition, much good Information was gained from a questionnaire conducted by the church to discern how the congregation would feel about coming together again. But perhaps the most valuable information came from the personal phone calls Board members made to members of the congregation.

As one Board member reported in response to calls to the congregation:

I have learned that we have an amazing faith community. People are diverse, resilient, committed, and deeply concerned about Knox-Met United. I understand more fully that I am embedded in a larger faith community and my welfare is ultimately and inextricably linked to the emotional, psychological and spiritual health and well-being of others.

It was a tricky balancing act. Safety and protection are important but so is an in-person worship experience that many people longed for. Finally, when the time seemed right, Board Members agreed that the church would resume in-person worship beginning October 4, 2020 with adherence to all protocols and pending Saskatchewan Health Authority Guidelines. We remained open for seven in-person services.

#### **Outcome of Being Closed**

During the past year, there was a loss of income from cancellation of fundraising activities, rental income and Sunday offerings. At the same time, many people found ways to make significant contributions to the bottom line, for which we are especially grateful. We are most fortunate as a church that Donna Nelson was approved as Treasurer at the 2020 AGM. Thanks to her knowledge and initiative, KMUC has been able to access over \$90,000 in COVID subsidies and other grants available to organizations such as ours.

Even though the church space has been closed to in-person activities, church events continued to take place, especially meetings via Zoom. KMUC hosted an anti-racist webinar attended by over 100 people and held episodes of Theology on Thursdays. Along with regular Sunday morning services, the congregation was treated to Knox Kids @ Home plus a mid-week compline service. Two weekly chat groups are on-going. Digital access has enabled regular attendance by people far and wide including some in Regina who have never been inside our church.

According to FaceBook numbers, there have been hundreds of views of our Sunday services and several more hundreds over the Christmas season.

#### **Next Steps**

The McNair Feasibility Study, commissioned by the congregation, was received in 2020. The Board sent it for discussion with members of the Trustees, Finance Committee, and Administration Ministry. A Zoom presentation to the congregation with a representative of McNair Business Development will take place in 2021.

In these highlights of KMUC, I wish to recognize the significant efforts of the congregation that have helped us to stay together as a community in these most of trying circumstances. Through phone calls, contributions of time and talents, expressions of concern and numerous on-going ways beyond what is mentioned here, we have held up each other's arms against the maladies going on around us.

We are most assuredly not alone. Thanks be to God.

## Board of Trustees

The Board of Trustees for KMUC are Carole Bryant, David Calam , Jim Garden – Chair, Bill Johnson, Bill Perkins (inactive), Barbara Shourounis – Secretary, Alison Stickland--Treasurer, Cameron Fraser – Minister

#### **Role of the Trustees:**

Trustees for Knox-Metropolitan United Church hold church property (i.e. land, building, investments, furnishings, equipment) in trust for the use and benefit of the Knox-Metropolitan congregation as part of the United Church of Canada. Responsibilities include: monitoring and proposing amendments to the church's investment policy; overseeing the professional management of the investment portfolio; ensuring that procedures are in place for maintenance and repair of church property; and ensuring that the church has adequate property and liability insurance coverage.

Trust funds may only be accessed when approved by the congregation (through the annual budget, or a duly constituted congregational meeting), or by resolution of the KMUC Board.

#### **Evolution of the Investment Portfolio:**

- In 2002 the church received a remarkable gift from Dr. Gerry Evenden of 154 acres of farmland on the eastern outskirts of the city with an appraised value of \$385,000
- Nine years later, in 2011, the property was sold for \$4,000,000.
- In October, 2012 An Investment Policy approved by the church Board provided for the establishment of a Trust Fund to be professionally managed with oversight and policy development by Trustees.
- On January 9, 2013 all existing trust funds and the proceeds from the sale of the Evenden property (\$4,165,599) were invested in a portfolio that is professionally managed by RBC Dominion Securities.
- Trust funds are currently held in the Conexus Credit Union or in the RBC Investment Portfolio.
- All bequests and any funds or securities designated for the trust are transferred to the Trust Account for management by the Trustees.

#### The Need for Financial Viability:

While 2020 has been a year like no other, the staff, the Board, the ministries, the congregation the United Church of Canada and many community partners have stepped up to the challenges created by the Pandemic. With remarkable creativity, faith, steadfastness and resilience, the church and its peoples have introduced new programming, developed new ways of communicating and meeting the needs of the congregation and communities we serve. We can look forward to emerging from this Pandemic much strengthened by our individual and collective experiences, knowing that we will adapt to whatever the future will bring and that we are not alone.

In whatever form we emerge from these unprecedented times we will undoubtedly continue to grapple with the costs of maintaining and operating our church building. Even during this time of church closure due to the Pandemic, expenses were greater than our income. Even though we were blessed with volunteer, and in-kind services, generous contributions from members, the proceeds of several estates, and many gifts and grants, we continue with the unsustainable practice of drawing on Trust Funds to cover operational shortfalls. New opportunities and challenges will continue to test our ingenuity, faith, strength and resources in 2021.

The congregation, the ministries, and our community partners are encouraged to recognize the need for financial viability and to continue participating in the life of the church and making contributions in whatever ways they can.

#### Activities in 2020

- Meetings were held with the RBC Investment Portfolio Manager in January and again in October, 2020 to
  discuss performance, future projections, strategic directions, compliance with and relevance of our current
  Investment Policy guidelines. It is the consensus of Trustees that RBC continues to manage our
  investments with professionalism, competence, and adherence to the guidelines. Randy Semenchuk and
  his staff have made extraordinary efforts to maintain open communications and provide relevant
  information to Trustees as requested.
- Arrangements were made for the re-appointment of Barbara Shourounis to represent the Trustees on the KMUC Board, and for the re-appointment of David Calam to serve as our representative on the Finance Committee. David also continues to serve as Chair of the Finance Committee.
- Trustees participated in meetings of KMUC Board members, Administration, the Finance Committee and others to review and comment on the final report and recommendations of the McNair Business Development feasibility study. A report was provided to the Board from the Trustees regarding views of the study and proposed next steps involving communicating the report and its recommendations to the congregation.
- At the 2019 Annual Meeting, the congregation approved an allocation of up to \$185,000 from the KMUC portfolio to cover the anticipated budgetary shortfall. However, due to significant shifts in revenues and expenditures associated with the closure of the church and the receipt of proceeds from several estates, several grants and the continuing generosity of members of the congregation, the budgetary shortfall was covered through the KMUC Trust Funds held in our bank account and no withdrawals were made from the trust funds held in the RBC Portfolio

#### **Finance Committee**

Submitted by David Calam – Chair

The Finance Committee is Debra Burnett, David Calam (Chair), Donna Nelson (Treasurer), Karen Haggman, Phyllis Perkins, and Ray Lutz. In addition, Carol Schick attends meetings in her role as Chair of the Board. The Committee met eleven times in 2020.

Finance Committee is a committee of the Board providing support and advice with respect to financial matters. The Committee's main assignments may be summarised as preparing and monitoring the annual budget, ensuring finances are reviewed annually, planning for year-round stewardship and fundraising initiatives and long-range financial planning and forecasting.

In 2020, Knox-Metropolitan's changing financial situation due to the Covid pandemic was an ongoing concern. The 2020 Financial Statements show the impact of the pandemic restrictions.

During 2020, the Committee supported our Treasurer's role, a large part of which was to become familiar with and improve financial record keeping, reporting and compliance. Knox-Metropolitan now has a policy and process for payment of part time staff and self-employed persons. The policy ensures compliance with Canada Revenue Agency and other government requirements.

Annual budget preparation is a major task. We are fortunate to have a group, Debra Burnett, Karen Hagman and Donna Nelson, who provide their experience and knowledge to this task.

Finance Committee is working to develop a full understanding of Knox-Metropolitan's financial processes and practices and is documenting these in a "Financial Handbook". It is intended that the Handbook will be helpful by adding a level of transparency and consistency to our church's financial processes.

## Ministries of the Congregation

#### Administration

The Ministry of Administration is Jim Garden and Keith Rever (Co-Chairs), Stewart Graham (Secretary), Joan Garden and Phyllis Perkins. We were pleased to welcome Greg Bamford as a new member to the Ministry this year and thank him for his valuable input, suggestions and contributions. Brian Brunskill, while no longer a sitting member, fortunately continues to "work behind the scene" to provide very valuable input in the various ongoing projects that take place around Knox-Met, which is greatly appreciated. Peter Ricci decided to step down as a member earlier this year. We sincerely thank him for his service.

**Mandate:** Overseeing the daily care, cleaning and maintenance of the entire church building, both interior and exterior; planning and arranging for renovations and repairs; the purchasing and maintenance of all office and janitorial equipment, as well as office and cleaning supplies; overseeing rental and use of Church facilities and establishing policies as required; hiring and managing the Church's office and caretaking staff.

Special Thanks to the following people: Stewart Graham, for his ongoing work as Chair of "Use of Church" and for his oversight in this role in dealing with church renters during both our shut down, as a result of Covid 19, and our ongoing re-opening plans. We also thank Stewart for his role as dedicated Secretary of Administration and for acting as our designated committee member for the review and editing of the McNair Report, as well as preparation of the letter notifying the Congregation of the report. Brian Brunskill, for his extensive work identifying the problem with the Gothic Stained Glass Windows, initiating the major work plan to repair them and also assisting Rev. Cam Fraser in applying for Heritage grants. Bob Ivanochko and the Grounds Committee, who worked tirelessly throughout a very hot and dry summer re-developing and expanding the Peace Garden, despite the restrictions of Covid19. Phyllis Perkins, for serving as the representative for Administration on the Finance Committee. Joan Garden, for her continued work overseeing all contract maintenance agreements and negotiating the best possible price for both the elevator and the waste management and recycling contracts, all of which came up for renewal this year. Also, for overseeing the purchase and installation of a new cylinder for the elevator, from contract negotiation to installation (cost \$65,100.). Finally, for being the "Go To" person on hand to troubleshoot when problems arose throughout the summer, of which there were many and include the following; water in the elevator shaft; broken sprinkler system; replacement of dead sod; investigated the removal of graffiti from the historic stone work (on-going); investigated the possibility of installing iron gates at Lorne Street entrance (on going).

This year Covid-19 had a significant negative impact on Knox-Met and a few of our related undertakings are outlined in the special Covid Report, (attached).

In closing, I would like to thank all members of Administration for their support and assistance throughout the year and in particular, **Keith Rever**, who continued to participate despite being in great discomfort leading up to his surgery for a hip replacement. Finally, this Ministry would be remiss if we did not thank Rev. Cam Frazer for his constant willingness to be involved in all aspects of the administrative and business work of our church.

#### SPECIAL COVID-19 REPORT 2020.

On Sunday March 15th of 2020 a special meeting of "The Board" was held immediately following the Church Service, where a decision was made to close the building due to the high risk of spreading the virus amongst group gatherings.

All renters were given notice and no one was allowed to enter the building except for the staff. We have been fortunate to have been able to retain all permanent staff positions to date. This is mainly due to available government wage subsidies for employers.

We thank **Donna Nelson** (**Treasurer**), who has been kept very busy throughout the year, keeping on top of what is available and applying for whatever subsidies we qualify for as a church. Carlos Olmos was employed on a six-month contract term which ended in June and was not renewed. It was an amicable agreement as his wife, Carol, was very ill and he needed to be at home with his family.

Had Knox-Met not qualified for government funding, it is doubtful that retention of all lay staff positions would have been sustainable, at least, in a full time capacity.

While the building was in lockdown, I took the opportunity and arranged to have the carpets cleaned throughout the building. After that, our janitor, Aaron, was asked to strip and wax the floors. So, coupled with all the extra cleaning and sanitizing required (re: guidelines) he was kept busy. Also, Hart and he took the opportunity to catch up on extra projects, one of which was clearing the stage in the Gym.

In early June, The Finance Committee requested that Administration carry out an assessment to identify the "Needs of The Building" during lockdown. Joan Garden volunteered to carry out this project. By speaking with Janice, Hart and Aaron, first individually and then as a group, it was identified that, **someone** needed to be in the building at all times during the day. However, it was not required that **all three** be in the building **All** of the time!

One major problem that was brought to our attention was the impact the lockdown was having on the exterior of the building. The problems identified were not necessarily issues we hadn't dealt with before. However, they had returned on a much larger scale with more frequency.

Graffiti users were back, spraying their hidden codes liberally all over the stone work at the main entrance. Also, the alcoves were being used as a public washroom. As previously mentioned, we are used to washing away urine, but now we were also dealing with human feces, which our staff had to clean up on a regular basis.

Various homeless people continue to take up residence on the front steps at the Lorne Street entrance and while this is more often a nuisance, the situation was exacerbated when the whole down town was under lockdown. There was no access to public washrooms anywhere! Stores were closed as well as most office buildings, including the Regina Public Library, which apparently was greatly missed, for more reasons than one.

This was also the summer and these types of issues are always compounded because of warmer weather when more transients pass through the city. None the less, we have not had to deal with anything quite like this on a regular basis.

It turns out that even though the usual hustle and bustle inside the building had fallen quiet and still, it was a far cry from the increased activity and work load that was going on directly outside! This, as well as other pertinent information was compiled in a four page report and submitted to David Calam, (Chair of the Finance Committee).

The other major project that this Ministry played a part in was the plan to re-open the building and resume inperson worship. Information from a report, which I submitted to Administration earlier in the year follows.

#### Updated Report on Safe Re-Open Plan for Our Church

#### Submitted September 15, 2020 by Joan Garden

It was a very busy summer for the group of volunteers who agreed to be a part of this process. **They include Rev. Cam Fraser, Elizabeth Calam, Liz Ivanochko, Jim Garden and myself, Joan Garden**. Cam has led the group throughout this time and kept us informed of all the Government of Saskatchewan guidelines and also the United Church of Canada guidelines for worship. The members of staff have also been included in some of our meetings. We have met on numerous occasions throughout the summer and accomplished a lot. However, there is still much to do as we move closer to a safe re- opening date for In-Person Worship and also allow access to the building once again, for private renters. Our next meeting will involve dealing with the latter and reviewing the individual renters plans and safety protocols, which they are required to submit for approval before a contract can be signed. The following is a list of some of the tasks that have been carried out over the past few months:

a) The Hymn Books have been disinfected and packed away;

b) The donation / contact envelopes and pencils have been removed from the pews;

c) Safe Distance Measuring for seating in the Sanctuary has been marked out as per the guidelines. Lavender coloured painter's tape was mounted on the backs of the pews to indicate where one is to sit in the pew;

- d) All the pews have been washed with soap and water;
- e) Sanitizing equipment and Sanitizing Gel was sourced, purchased and installed; and

f) Covid-19 Signage is in the process of being either ordered or made. Cam is working on this project, as he intends to produce some of the signs himself. Others will be ordered, such as the adhesive ones for the floor area. Print West and Western Litho Printers are the companies we have spoken with. Also, I understand Cam has used Staples.

A test "Walk Through" was held on September 10th which essentially put our strategic plan for a safe reopening for worship into operation. The Board members were invited to attend as the congregants. Each was required to register on-line, prior to attending. Five volunteers were involved in total including two ushers, one greeter / registrant, who was required to check that all information was in place for tracking purposes. Sanitizing Gel was available on the table. One volunteer was located at the bottom of the stairs to spray each person's hands with sanitizer prior to directing them to proceed up to the Narthex. One more volunteer was stationed at the top of the stairs in the Narthex to oversee the bulletin table and also offer more sanitizer. The test run seemed to go quite smoothly but our next meeting will reveal what we need to change or improve. The Board also meets this week and they will offer their feedback and hopefully approve **The Plan to Re-Open**.

The total cost for Safe Re-Opening Supplies amounted to approximately \$1500.00.

#### Use of the Church Committee

Use of Church Committee operates as part of the Ministry of Administration.

During the past year, due to Covid-19, the church earned only \$18,660.70 rental and wedding income, plus \$480.00 for security. The security costs associated with this income were \$510.00 resulting in net income of \$18,630.70 for the year. In the future Administration and Caretaking Staff costs applicable to this category will be factored into the calculation.

The Covid situation has not yet been resolved but ongoing contact is being maintained with all renters to reestablish our relationship with as many as possible as soon as we are able to reopen our space for rentals.

Our church is a wonderful venue that satisfies the rental requirements for a wide variety of tenants who find our location well situated and very accommodating.

Each year we provide to the Regina Anti-Poverty Ministry (RAPM), without charge, office space, heat, light, maintenance, cleaning services, and parking, to a value of \$13,000.00.

Janice Diemert and Hart Godden provide excellent support for our rental program and capably handle the various rentals in a most satisfactory manner.

In 2020 we were unable to deliver Christmas trees to our "shut-ins". But as we were all now technically "shutin" Congregational Life and Pastoral Care decided that a Christmas card should be sent to everyone! My thanks to Iris Carroll who helped prepare the cards.

If anyone could help with the phone team, please call the office and we will be glad welcome you. The more phoners we have the fewer calls we each make.

#### Word Worship Music and The Arts

In December 2019, the World Health Organization had been monitoring a health crisis and on March 12, 2020, a pandemic was declared. It resulted in lockdowns and restrictions which effected our homes, communities, country and the world. Knox-Met was no exception to these lockdowns as all gatherings, funerals/weddings, meetings, and worship services were suspended due to the lockdowns and restrictions implemented by Saskatchewan Public Health. The last meeting of WWMA was held on March 11, 2020 @ 2 pm at the church. WWMA did not meet until 10 months later, which was held on Zoom (on-line) on January 20 @ 1 pm. A special Thank you to Cam Fraser (minister) and Hart Godden (Director of Music) for their leadership, hard work and perseverance to continue worship (on-line or in-person) through these unprecedented times.

#### 2020 Review:

#### **Services and Activities**

March 15 - last service in the sanctuary with the full congregation (Lent 3). March 22 - on-line services began (Lent 4).

- 7 pm Sunday Vesper Services were streamed on-line using Cam's phone; not only did it fall into the Lent theme but was focusing on the pandemic and the 'space between us".
- 7 pm- Wednesday Meditations from Cam's front porch or the sanctuary balcony were streamed online.
- 10:30am Sunday morning Kid's Service streamed on-line from Cam's house.
- Holy Week

- Maundy Thursday 7 pm on-line service; communion shared but people provided their own elements in their own home.
- Good Friday 7pm online service.
- Easter Sunday 10:30 am; online service.

Note – both our Palm Sunday, and Good Friday evening Services were picked up and shared by the United Church of Canada Social Media accounts resulting in a 1,100 and 1,400 views respectively.

On Easter Sunday a special afternoon concert was provided by the Regina Bell Ringers on the Darke Memorial Chimes. Shortly thereafter the bells began being rung on a regular basis including special Sunday evening conerts throughout the season of Advent!

**April to September** - 10:30 am Sunday morning services continued to be streamed on-line. From June to September, farm garden flowers were donated by Leslie Hall (Lark Farm) for the on-line services. After the service, Elizabeth Calam and Deanna divided the flowers into small bouquets and delivered them to shut-ins and other congregation members; 42 bouquets were delivered and well received.

**October 4 to November 8** - in-person services resumed following the restrictions and guidelines issued by Saskatchewan Public Health; our on-line services continued to stream while the in-person services were happening; the Re-Open Knox-Met committee did a tremendous amount of work to ready the sanctuary and volunteers for in-person services following guidelines issued by the Saskatchewan Public Health. Choir members (in smaller groups of 5 to 10 people, wearing masks and physically distanced in the choir loft) volunteered to lead the singing. An average of 35 people attended the Sunday in-person services which included the volunteers (who ushered, carried out the required medical questionnaire, and monitored the entrance, seating, and leaving the sanctuary), the reader, musicians and Cam. These services were suspended again in mid-November due to further Public Health restrictions with on-line services continuing to reach our community.

After the first in-person/online hybrid service a special decication of the Knox-Met Peace Garden was held on a beautiful October afternoon.

One baptism was held during 2020 following public health guidelines and took place in the afternoon after the service had taken place in order to manage numbers.

December 21, Monday - The Longest Night of the Year - A Service of Grief and Thanksgiving, Remembrance and Peace, remembering loved ones lost over the years with music by Hart Godden (organ) and Aaron Balkaran (tenor soloist).

Christmas Eve services - pre-recorded with rented equipment.

- 5 pm Follow Yonder Star Kid's Pageant which aired at 9 pm because of technical difficulties.
- 7 pm Gather Around the Manger based on the 'usual' 10:30pm format (minus communion) with music by Hart Godden (organ) and vocal duet (Jessica and Victoria Stroeder), candles, readings by Monique Poisson-Fast and Bill Johnson.
- 10 pm Mary Treasured These Things in Her Heart a quiet meditative service with readings and music; Readers: Cecilia Prokop, Vicki Nelson, Morgan Campbell, and Julian Wotherspoon; message by Cam; music by Hart Godden (organ), Cameron Lowe (cello) and Tara Semple (flute and singing bowls).

Zoom Coffee Time is being held after the morning service with a guest speaker each week; organized by Dan Coggins; has good conversations and attendance; currently continuing after the on-line service.

On-Line Bible Studies and Thursday night series discussing the "Song of Faith".

**Decorations**: Lenten decorations were in place when the pandemic hit. For the remainder of the spring Hart became the 'decorator apprentice' as Deanna, to keep safe and able to visit her mother, did not come into the building while others were there. With the Re-opening of Knox-Met and the modified in-person services resuming, Deanna stepped back from doing the decorating in the sanctuary for a break after 8 years of the weekly responsibility. Thank you to Liz and David Calam have been doing the weekly church decorating since October and have done a fantastic job especially through Thanksgiving and the Christmas season. Our thanks also to the Ricci family for their assistance decorating the front of the sanctuary for Christmas.

Our Ministry thanks all those who have worked so hard to keep our members safe throughout this time. We all look forward to "returning to normal", whenever that may be.

## **Refugee Committee**

The Refugee Committee is Amanuel Abraha; Emily Buena; Dessie Gebreyesus; Minni Maskel; Eliud Meles; Donna Nelson; Rod Nenson; Girma Sahlu; Yergalem Tesfay (Tessie); Marlene Wirachowsky, Secretary; and Donny Woods.

The Refugee Committee started the year in an optimistic outlook. Aynalam Mitiku Gebre arrived on Feb 27 and settled in comfortably with her cousin. WE agreed to co sponsor 10 of the many requests we received covering 17 people as we had received a major portion of the required funding the Board approved the requests. The committee also had a list of additional requests we hoped to accept, some put the funding in trust with Knox-Met.

As we were working on these requests, COVID 19 struck. Policies and procedures changed at the government level and at the National Office of the United Church. It also affected our collecting of documents and information for completing the forms. For a while we had small working groups with 3 or 4 people but almost stopped working by late fall except for emergencies.

We had a couple of emergencies. We received a call that a young man supposed to be in Regina was stranded in Moose Jaw. Luckily, we were able to accommodate him remaining in Moose Jaw with financial and personal support. He is now working and studying there. Another problem was our expectation to have a young man arrive from Israel on March 17 but international travel was shut down three days before.

Ande came to Canada a few years ago as a refugee but did not declare that he had a wife and 5 children which normally eliminates the possibility of reuniting the family. The Canadian government has opened a 2 year window to solve some of these cases. Ande is expected to cover the settlement costs and ongoing living expenses for the family until the youngest child reaches adulthood. Since Ande is handicapped we have been helping get pro bono legal advice about reunifying the family on compassionate grounds.

There are different ways to sponsor refugees. At present we are a Constuent Group with the National United Church status as a Sponsorship Agreement Holder (SAH). They have a quota of sponsorships and a backlog.

We decided to try another method called Community Sponsorship (CS). Community organizations including churches can use the CS system and work directly the Canadian Immigration system. We hope it will speed up the process and increase the number of requests we can make. There are some restrictions about the type of documents the refugee has and some additional paperwork is required. We forwarded one application which was rejected because the type of refugee status is not accepted through this process buy might be accepted under the SAH process.

Thanks to the contributors to the Refugee Fund and to Outreach for their financial support. Thanks to the committee members for their interest and support. Special thanks to Donna and Dessie and Tessie and Marlene. Thanks also to Pablo Echavarria for his assistance with computer applications.
