Carol Schick read out the name of members who passed away in 2018. We observed a minute of silence.

## 4. Election of chair/secretary of the Annual Congregational Meeting

Moved/seconded by Gilda Graham/Stewart Graham that Carol Schick be elected as chair and Victor Lam be elected as secretary of the meeting of the congregation. Carried.

#### 1. Call to Order –

Carol Schick, Chair of the Board, called this Congregational Meeting to Order.

Quorum of 20+ members was verified by Kathleen Johnson and Elizabeth Stroeder.

#### 2. Opening Prayer –

Cameron Fraser, Minister, led the meeting in prayer.

#### 3. Reconfirmation of Chair / Secretary of Congregational Meeting -

Moved / Seconded by Elizabeth Ivanochko / Alison Stickland that Carol Schick be the Chair of this Congregational Meeting. Carried.

Moved / seconded by Elizabeth Ivanochko / Elizabeth Calam that Elizabeth Stroeder be the Secretary of this Congregational Meeting. Carried.

#### 4. Decision on the Participation of Adherents

Moved / seconded by Gary Seib / Barbara Shourounis that adherents be allowed to participate in this Congregational Meeting. Carried.

#### 5. Approval of Agenda –

Moved / seconded by Vicki Nelson / Donna Nelson that the Agenda be approved. Carried.

#### 6. Background Information on Being There When the Future Comes -

David Calam gave an explanation regarding the history and mandate of the Being There When the Future Comes Committee. He outlined many of the past activities undertaken by the BTWTFC Committee, and what they plan to undertake in the near future.

The committee will try to answer the question: "How can we best use our building and our property to meet our needs?"

The BTWTFC Committee recommends hiring McNair Business Development Inc. to carry out a feasibility study to determine what options Knox-Metropolitan United Church has for future development.

#### 7. Motion to hire McNair Business Development Inc. -

**Motion:** The Congregation of Knox-Metropolitan United Church agrees to continue the work of future planning, currently under the banner of **Being There When the Future Comes** by engaging the services of McNair Business Development INC. to conduct a Feasibility Study to determine the viability of our current trajectory in future planning of moving towards a more intentionally multi-functional and partnership-driven organizational structure for the use of the church building, and help create a plan to inform the on-going work. The fee for this work would be \$28,000.00.

The above motion was moved / seconded by Barbara Shourounis / Dan Coggins. There was discussion regarding this motion, along with several questions. Points to note are:

- McNair will provide Knox-Met with one plan which will include three (3) scenarios;
- McNair was the only firm approached and asked to provide a study of this kind:
- The study will be funded by a special fund, established in 2012 and administered by Trustees, to be used for projects undertaken as part of the BTWTFC initiative;
- Knox-Met is looking for potential investors to take part in the church's future planning.

The vote: All in favour; no abstentions; none opposed. Carried.

#### 8. Adjournment -

Bruce MacDonald moved that the meeting be adjourned.

## **DRAFT – Minutes of the Congregational Meeting – Affirming Ministries**

Sunday, February 9, 2020

#### 1. Call to Order

The meeting was called to order by Carol Schick, chair of the Board at 12:09 pm. Quorum (20 full members) was confirmed by show of hands

*Request by Joe Stroeder to amend the agenda was ruled out of order until the Approval of Agenda (Item #5).* 

#### 2. Opening Prayer

Cam Fraser led us in an opening prayer, a few moments of silence followed by A New Creed read aloud by those in attendance

#### 3. Confirming the Chair/ Secretary of the meeting -

Moved by Stewart Graham/Shelleen Ross that Carol Schick be confirmed as chair of this meeting. Carried.

Moved by Barbara Shourounis/Bob Ivanochko that David Cawood be named as secretary for this meeting. Carried.

#### 4. Question of Participation of Adherents

Carol read the definition of Adherents from The Manual (2019)

Moved by Cathy Currey/Peter Ricci that adherents be invited to fully participate (including vote) in this meeting. Carried.

#### 5. Approval of the Agenda

Moved by Elizabeth Calam/Dan Coggins to accept the agenda.

Moved by Joe Stroeder/Liz Stroeder that the Agenda be amended to include item 5a) Decision to hold vote on Affirming Ministry by Secret Ballot.

Amendment Carried. Approval of Amended Agenda Carried.

#### 5a. Question of Voting by Secret Ballot

Moved by Liz Stroeder/Joe Stroeder that voting be conducted by secret ballot. Discussion. Carried with 34 in opposition.

#### 6. Presentation by Affirming Ministries Group.

Karen Haggman on behalf of the Affirming Ministries Group offered a presentation which outlined the process that the AMG took in exploring Knox-Metropolitan becoming an Affirming Ministry. She read the "Statement" prepared by the AMG and outlined the various changes and edits that they took to its final form. She thanked those people who offered feedback and suggestions.

Comments and discussion from the congregation.

#### 7. Motions on Becoming an Affirming Congregation

The Chair explained that the Board had prepared a ballot with 3 questions and that 75% approval would be required on all 3 questions for the Board to request that Affirm United declare KMUC an Affirming Ministry. The 3 questions would be voted on all at once and counted separately with the results announced separately, noting how many votes were cast, how many yes, how many no, how many abstain.

The ballot was shown on the screen.

Moved by Joe Stroeder/Barbara Shourounis that three separate ballots be used and that question 1 be voted on, tallied and result announced before moving onto before onto question 2 and that this procedure be repeated for questions 2 and 3. Motion defeated.

Moved by Stewart Graham/Liz Stroeder that question #1 appear on the ballot as The Congregation of Knox-Metropolitan United Church become an Affirming Ministry of the United Church of Canada and join Affirm United/S'Affirmer Ensemble.

Moved by Liz Stroeder that Question #1 be amended to remove the words "and join Affirm United/s'Affirmer Ensemble".

This motion was ruled out of order because it would void the intention of the motion because an Affirming Ministry is, by definition, a Ministry that has been recognized by and become a member of Affirm United/s'Affirmer Ensemble..

Ruling was accepted and Liz shared statement to the congregation about Affirm United.

Moved by Vikki Nelson/Barbara Shourounis that we proceed to the vote of question #1 without further discussion.

Carried with over 2/3 voting in favour.

Joe Stroeder objected to the question being called. He challenged the Chair's ruling.

David Cawood as Secretary called the question on whether to sustain the Chairs ruling to proceed without further discussion on Question #1. Carried.

Moved by Vikki Nelson/Cecilia Prokop that question #2 appear on the ballot as *That the Congregation adopt the proposed Affirming Statement.* 

Moved by Cecilia Prokop/Julian Wotherspoon to proceed without discussion on Question #2. Carried with over 2/3 voting in favour.

Moved by Michael Parker/ Bonnie Morton that question #3 appear on the ballot as *That the Affirming Group continue as a committee of the Board* Carried.

Cam Fraser explained that the Board had designated Barbara Shourounis and Liz Ivanochko to count the ballots and Marlene Wirachowsky to act as scrutineer. In Liz's absence Barbara had asked Mark Wartman

to act in Liz's place. The Congregation agreed by consensus to this arrangement. Cam clarified that neither Carol nor he vote.

Ballots were distributed by the counters.

Ballots were collected by the counters.

The Ballot Counters and Scrutineer moved to a table set up in the corner of the room to count.

Attendees at the meeting were asked to remain after the announcement of the result for a closing statement and prayer to follow the formal adjournment of the meeting.

Barbara Shourounis announced the results of the vote.

Question #1: That Knox-Metropolitan United Church become an Affirming Ministry and join Affirm United/S'affirmer Ensemble.

Votes Cast - 81 Yes - 65 (80%) No - 14 Abstain – 2

Question #2: That Knox-Metropolitan adopt the proposed Affirming Statement (see Appendix 2)

Votes Cast - 81 Yes - 67 (83%) No - 11 Abstain - 3

Question #3: That the Affirming Ministries Group continue as a Committee of the Board.

Votes Cast - 81 Yes - 65 (80%) No - 12 Abstain - 4

#### 8. Closing Words and Adjournment

David Cawood moved to adjourn the meeting at 1:50 pm, Shelleen Ross thanked everyone for sharing their thoughts and for attending the meeting.

Cam Fraser invited the congregation to breathe deeply together and the acknowledge that the congregation has spoken with clarity about a desire to become an Affirming Ministry. He acknowledged that this has been a difficult meeting and a difficult way to end this process. He noted that there was much consternation today and that there was a need to process and heal from this together. He announced that in the coming weeks that conversation circles would be held for people to speak together about their feelings. He acknowledged that regardless how one voted that the congregation was encouraged to seek good ways to move forward together in the direction that had been decided today.

Cam closed with a blessing.

## Minister's Report – Signposts on our Journey towards the Future

Dear Friends and Partners in Ministry;

I write this just before Transfiguration Sunday, which bridges the gap between the Season After Epiphany and the Season of Lent, one of the signposts on our Tradition's Journey towards Easter and Resurrection.

Our Tradition has many signposts, speaking to us from the outside inviting us to attend to the journey within, to ask ourselves deep questions about the journey we find ourselves on. Lent invites us in particular to ask these questions – to look at what might be learned from disappointment, regret, our own short-comings, even sadness and loss!

2019 was a year of many signposts along the journey we find ourselves on as a Community of Faith!

A Joint Needs Assessment (JNAC) report was accepted by the congregation in January affirming direction for my role as Minister, and the need to further invest in our ministry with children and Families through the creation of a Child and Youth Program Coordinator.

In the late winter and into the spring, the Affirming Ministries Group opened up space for learning with guests from Wesley United Church (the most recent Affirming Ministry), and then a Congregational Conversation to explore the Affirming Statements of Regina's other Affirming Churches.

A major signpost on the journey for me personally was reaching 5 years of ministry with you all in May 2019 which also meant that I would be eligible for a 3-month sabbatical. Our trusty Subaru Forester towed Tumbleweed, our 1972 fiberglass, Boler Trailer over 13,000km (through two broken axles and lots of cupboard doors falling off) to the Yukon, the Arctic Ocean, a 700km ferry ride on the Inner passage off BC's coast, around Vancouver Island, into the Rockies and back to Regina 101 days after we'd left!

We saw lots of signposts!

We also looked within to ponder the journey. Cheryl and I moved here with a 22-month old Lily and a 4week old Isla. They are now 7 and 5 and a whole other human, 22-month old Oliver has joined our gaggle!

We've learned that although we miss trees, the Prairies speak to us, and the Living Skies are feeling more and more like home all the time!

We also attended to the experience of sharing family with a thriving (and occasionally quite timedemanding) community of faith, and all the blessings and challenges that go with that. We got to think about where we see things progressing, and imaging what sort of church we hope our children will get to inhabit as they grow over the next decade.

While we were gone, the community of Knox-Met got to ponder the important significance of the ministry of the laity, and learn to work with other Ministers in the Revs. Jan Temple-Jones, and Christa Eidsness

The Community also celebrated a special sign post of 25 years of music ministry with Hart Godden, and the 50<sup>th</sup> Anniversary of the beloved Cassavant Organ - now with even more pipes.

Throughout all of this, we continue to attend to what these signposts are telling us about where we are heading as we seek to Be There When the Future Comes.

2019 ended with over 400 people worshipping at 3 services on Christmas Eve, and we notice that each year we see more and more folks coming on this night who do not attend at other times in the year – in fact, they currently far outnumber regular KM folk during these services. What does that tell us about our call to be church, to provide space on this special night for the community beyond our membership? What a gift!

Although my letter is intended to cover 2019 only, I cannot help but name two important signposts on our way in these first months of 2020. We have intentionally continued our Being There When the Future Comes Project through working with McNair Business Developments Inc, and we have voted to become an Affirming Ministry.

Our work with McNair is inviting us to ask deeper questions about what we might be open to in the future, what we might be willing to take on and what that might require us to give us.

Our vote to become an Affirming Ministry was a challenging moment for many. While we are able to celebrate that those gathered on February 9 made a clear choice to move forward, there is confusion, hurt and frustration amongst many, both those who voted yes and those who voted no. We have some listening to do – feelings to attend to, and some things to learn about each other as we move forward. We also deserve to celebrate this, to recognize that hard work was done, and deep listening occurred, and that we discerned what we believed was the next faithful step for us as a community of faith.

Being on the road for 3 months is disorienting and clarifying all at once. I return with a sense of hard questions we must ask ourselves about past patterns of being, and our seriousness about a desire for a future that looks different from our past and present. In a recent conversation over tea with Rabbi Jeremy who ministers with our siblings and friends in Beth Jacob Synagogue, he spoke about how the Rabbis speak of the future as that which is behind, and the past as that which is ahead – as a former rower, this makes perfect sense to him.

This is 2020, a year for hindsight, and if we can embrace that learning from where we have been, perhaps together we will make the steps we need, in order to be where we hope to arrive, when the future come.

Yours in our Shared Ministry – celebrating our call to be Church – and remembering that we are not alone!

# **Report from the Chair of the Board**

This year we have been very well met. We have gathered to deliberate, debate, decide and to celebrate. As a church community, we have come together on matters of business and faith that concerned us deeply. The spirit of the church is very much alive in each of our discernings.

What follows are only some of the activities that constitute the church year, 2019.

**January:** The year began with a very significant piece of business at a Congregational Meeting where we voted to accept the recommendations of the Joint Needs Assessment Committee:

- Keep one full-time minister who will act both in the function of spiritual leader/companion/instigator while also being a major change/vision sponsor.
- Hire part-time personnel (for communications support and a Sunday co-ordinator for children and youth) to assist the current minister.
- Hire outside organizations to help us achieve our visions of a vibrant sustainable future.

The Board added a final motion: that the congregation invite Cameron Fraser to continue his appointment to the position of Minister.

**February:** It turns out that we are getting younger and more numerous. Our numbers are growing and many new people are children. We are blessed by newcomers of every age.

**March:** The Affirming Ministries groups opened spaces for dialogue, questions and conversation about whether becoming an Affirming Ministry is a faithful response to our visions of welcoming and inclusivity. They hosted learning sessions after church on two Sundays. Our friends at Wesley United Church described the overwhelming success of their activities and eventual vote (it was unanimous). Jacq Brasseur from U R Pride offered their own experiences of being a faithful member of the Catholic Church while coming out and being a member of LGBTQ2SIA+.

**April:** Reverend Jan Temple-Jones began a five-week series of sessions on the topic of Spirituality and Aging. The sessions invited participants to explore the possibilities and challenges that spirituality presents in the second half of life.

At the end of the month, in preparation for the annual Book and Music Sale, volunteers once again performed the magical feat of turning the lower hall into a book and music emporium. It is safe to say that volunteers actually have a good time working together and raising money, not to mention first pick of the books. Volunteers welcome!

**May:** The church was the scene of an Iftar dinner hosted by our friends in the Muslim community. Members of the wider non-Muslim community also attended. This is the third year KMUC has been so honoured. The Annual General Meeting held on May 5 was the occasion for the first presentation of the annual budget by the Finance Committee. The newly formed Committee has been an asset to church governance, especially in the absence of a treasurer for the past two years.

**June:** We were ably represented at the first Annual Meeting of the Living Skies Regional Council. Our thanks go to our representatives Mari-Anne Berriault, Don Henrickson, and Collette Forbes.

The Affirming Group invited the congregation into an evening of conversation starting with pot-luck supper. Small groups were formed and reformed to take up the question: "What would you like to say to the rest of the congregation about Affirming Ministries?" The conversations were wide-ranging, but in general, there was satisfaction in being able to speak together on this topic.

**July:** Jan Temple-Jones was contracted to offer a cross-generational Vacation Bible School for families, little ones, seniors, and couples to learn and grow together in community. The VBS program consisted of singing, crafts, stories from scripture and sharing a meal together.

**August:** Cam Fraser began his 3-month sabbatical from August 1 to October 28. This is a benefit to which ministers are entitled after a 5-year service in one congregation. During this period, the congregation engaged Reverend Jan Temple-Jones to fill a 30 hour/week appointment focusing on worship leadership, pastoral care and maintaining forward momentum and good governance. Jan preached Sundays with the exception of the 1<sup>st</sup> Sunday of each month when the Rev. Christa Eidsness was present as our preacher.

During the sabbatical period, Cam and Cheryl's family of five planned to travel throughout western and northern Canada in their Boler trailer.

**September:** In September, a group of friends and fans came together as a planning group to host an after-church celebration to recognize the 25<sup>th</sup> anniversary of Hart Godden in his position as Music Director at KMUC. There were heart-felt speeches, fun songs and letters of recognition from officials beyond our walls including Moderator Richard Bott. The event was a tribute to Hart's faithful offering of "Music for the Soul", as celebrated in the KMUC motto.

Fall workshops were announced:

Josh Campbell: "Returning to Eden: How Deconstructing One of Our Foundational Stories Can Lead Us to a Sustainable Future"

Dan Coggins: "Grow Your Church"

Rev. Shawn Sanford Beck: some topics include Christian Animism and Ecumenical Companions of Sophia

**October:** Being There When the Future Comes investigated the hiring of McNair Business Development as a way to move forward with the process of how we might make the best use of our building. In spite of measured and careful attempts to do this work on our own, It was recognized that we now require outside expertise to move our process along. The proposal to take up this initiative would be brought to the congregation in 2020 for their approval.

At the end of the 3-mont sabbatical, the Hymus-Fraser family returned home from travelling and with their experiences with land issues, human rights and the beauty and sadness of our country more deeply engraved on their hearts.

**November:** On November 10, KMUC celebrated the 50th anniversary of its grand Casavant pipe organ by hosting the event "Organ Celebration and Hymn Sing". The wider Regina community was welcomed to the Sunday afternoon concert of choral pieces, choir and congregation hymn-singing and expert solo organ performances that called on the best of the organ sound. We received a congratulatory letter in recognition of the organ's 50 years from UCC Moderator, The Right Reverend Richard Bott. During 2019, the organ was upgraded by the installation of new pipes as part of an on-going project to bring the organ to its full completion.

**December:** Besides the contemplative Advent services and the glorious celebrations of Christmas, the end-of-year work of the church was also found in advertisements for a Children and Youth Coordinator Position as well as a Communications Position.

There is much to celebrate at the end of the year for Knox-Met even in the midst of many challenges. As in the best organizations, these challenges can be addressed through mutual support and a vision beyond one's own interests. We are blessed by scores of volunteers who do their very best by carrying out their chosen tasks and by offering their financial support. It is my hope for KMUC that the spirit of generosity in all of us will continue to prevail.

## **Board of Trustees**

## Submitted by Alison Stickland

#### Role of the Trustees:

Trustees for Knox-Metropolitan United Church hold church property (i.e. land, building, investments, furnishings, equipment) in trust for the use and benefit of the Knox-Metropolitan congregation as part of the United Church of Canada. Responsibilities include: monitoring and proposing amendments to the church's investment policy; overseeing the professional management of the investment portfolio; ensuring that procedures are in place for maintenance and repair of church property; and ensuring that the church has adequate property and liability insurance coverage.

Trust funds may only be accessed when approved by the congregation through the annual budget, or by resolution of the KMUC Board.

## Board Member's Responsibilities:

- Jim Garden, Chair
- In addition to serving as Secretary, Barbara Shourounis, is leading a review of the investment policy and the relationship with RBC. Barbara also serves as the Trustees' representative on the KMUC Board, replacing Carole Bryant
- David Calam continues to serve as the Trustee representative on the recently formed Finance Committee and is chairing the Committee.
- Bill Johnson, working with Jim Garden, has assumed responsibility for oversight of the church's insurance policy and contractual arrangements with renters
- Alison Stickland is serving as Treasurer

## Evolution of the Investment Portfolio:

- In 2002 the church received a remarkable gift from Dr. Gerry Evenden of 154 acres of farmland on the eastern outskirts of the city with an appraised value of \$385,000
- Nine years later, in 2011, the property was sold for \$4,000,000.
- In October, 2012 An Investment Policy approved by the church Board provided for the establishment of a Trust Fund to be professionally managed with oversight and policy development by Trustees.
- On January 9, 2013 the proceeds from the sale of the Evenden property and all existing trust funds (\$4,165,599) was invested in a portfolio that is professionally managed by RBC Dominion Securities.

#### The Vision is Becoming a Reality

Significant progress is being made and positive change is occurring at Knox-Metropolitan United Church. Our congregation is growing. We are welcoming newcomers into all aspects of the life of the church. Many young families and children are involved in worship and a growing number of programs. Strong community connections are being made and mutually supportive relationships are being formed. Music is at the core of our being. We have welcomed and supported refugee families and are having conversations that matter about justice, diversity, reconciliation, spirituality and much more.

## The Need for Financial Viability:

While so much positive change is unfolding, we continue to grapple with the rising costs of maintaining and operating our church building. Expenses are greater than our income. We continue to draw on investments to cover operational shortfalls. As the principal is eroded, so too is the earning power of the investments.

The practice of withdrawing from Trust Funds to bolster revenues is not sustainable. The church will not be able to achieve its goal of being a growing, *self-sustaining Christian presence in downtown Regina* (being there when the future comes) without a significant shift in financial arrangements.

The creation of the new Finance Committee in 2018 with accountability directly to the Board was a significant step in the right direction.

The congregation, the ministries, and our community partners are encouraged to recognize the need for financial viability and to continue making contributions in whatever ways they can.

With faith, courage and mutual support we can continue growing, participating fully in the life of the church and achieving financial goals while serving the needs of our community.

#### Activities in 2019

- A comprehensive review was undertaken of the insurance policy and insurance-related contractual arrangements with renters. Several changes were recommended to and accepted by the Administration Committee including the addition of coverage for the stained glass windows and Darke Memorial Chimes.
- A review was undertaken and substantive agreement reached resolving differences between the KMUC Investment Policy and the RBC Dominion Securities investment policy statement which is subject to the Investment Industry Regulatory Organization of Canada (IIROC).
- A draft was prepared of a revised KMUC Investment Policy. Further work will be done on the revisions in 2020.
- At the request of the KMUC Board, Trustees undertook a review of the McNair Business Development proposal agreeing that a feasibility study is the obvious next step in the process of discovering how to 'Be There When the Future Comes". Price, work plan and delivery date seemed reasonable.

# **Ministries of the Congregation**

## Administration

Submitted by Stewart Graham

The mandate for the Ministry of Administration is to care for the physical property of the church including:

- Overseeing its daily care, cleaning and maintenance,
- Planning for, arranging, and overseeing renovations, repair and maintenance projects,
- Developing for Board approval, policies for the rental and use of Church facilities, and updating those policies as required.
- The Administration Ministry is also responsible for hiring and managing the Church's office and caretaking staff. The Ministry works with the Ministry and Personnel committee with respect to ongoing performance of Church staff.

This past year we lost two valued members of our Ministry - Gary Seib and Brian Brunskill. We thank them both for their contribution to the ministry of the last number of years. (Thanks to his extensive knowledge of our building, Brian continues to work "behind the scene" to assist with various tasks.)

As indicated by our mandate there are numerous ongoing activities in and around the Church that require our attention.

During 2019 these included:

- Working closely with Janice and Hart arranging the numerous rentals.
- Submitting to the Board for their confirmation, the annual update of the Use of Church Policy and Guidelines, including review of rental pricing with notices sent to all renters.
- Installation of new LED bulbs under the balconies, stairwells, hallways and gym. Bulbs purchased by Stewart and Gilda; Hart arranged a work party for installation.
- Installation and upgrade of new LED emergency lighting at all exits. Cost \$8936.
- Purchase of 12 additional folding tables. Cost. \$2164.
- Upgrading and lining of all return-air tunnels to ensure proper drainage and reduce moisture levels. Cost \$1043.
- Refurbishing ceiling in room 201 used by Sunday School. Cost \$666.
- Purchase and installation of new blinds in office and Ministers office. Cost \$535.
- Arranged for touch-up painting in lower assembly hall and main floor hallways. Cost \$912.
- Reviewed fire insurance coverage with Trustees and approved amended coverage necessary to properly protect Church assets. This included an appraisal of the stained-glass windows.
- Reviewed Organ Project prepared by Hart Godden. Supported same. Sent our recommendation to the Board and Finance.
- Obtained, at no cost, an Energy Assessment of our building prepared by the Saskatchewan Environmental Society, which outlined steps we can take to reduce our energy costs.
- Negotiated employment contract for weekend caretaker.

- Arranged repair of exhaust fan in ladies LAH bathroom. Cost \$556.
- Assisted in the acquisition of a new software program utilized to track donations and prepare tax receipts.
- Worked with City on the Victoria Avenue rehabilitation project and how it impacts our Church.
- Worked with Sask Power when they were working in the alley behind our Church, and arranged for paving parking lot.

## **Use of Church Committee**

Use of Church Committee operates as part of the Ministry of Administration.

During the past year, the church earned rental and wedding income of \$60,155.00. This represents 11.9% of the total church revenue earned for the year.

Our church is a wonderful venue that satisfies the rental requirements for a wide variety of tenants who find our location well situated and very accommodating. We have 28 regular renters and numerous occasional renters.

Each year we provide to the Regina Anti-Poverty Ministry (RAPM), without charge, office space, heat, light, maintenance, cleaning services, and parking, to a value of \$13,000.00.

A number of our major renters of space are the Regina Philharmonic Chorus, South Saskatchewan Youth Orchestra, Cecelian Chamber Series, Regina Taiji, and Weight Watchers. We rent space to a number of 12 Step Program groups and numerous other entities such as: Regina Folk Festival, Per Sonatori, Halcyon Chamber Choir, Prairie Cello Institute and Osi-Can Support (a mental health support group), Queen City Brass, and Toastmasters. This year the Regina Rotary Club celebrated their 79th annual Christmas Carol Festival at our church.

If you are interested in the various renters take a look at the schedule posted in the hall near Janice's office. You will be amazed at the wide variety of entities who rent from us and how busy Janice is in organizing space for them all.

Janice Diemert and Hart Godden provide excellent support for our rental program and capably handle the various rentals in a most satisfactory manner.

Another delivery was made in December, when our beautiful little Christmas trees were delivered to 30 members by a team of 17 volunteers. With these trees were lovely Christmas cards made by the children of the Sunday School classes. These are always a big hit! ## **Outreach and Social Action**

The KMUC Outreach and Social Action Ministry meets the second Wednesday of each month (except July & August) at Knox-Metropolitan United Church (KMUC). Anyone can join – a good way to learn more about activities of this ministry is to drop in at one of the meetings. In 2019 two long-term members stepped down: Bill Quick because of health issues, and Joyce Wells moved to BC. This report outlines many of the 2019 Outreach activities.

Many Outreach activities are done by working in relationship with groups and organizations already dedicated to helping others. These activities include:

- 1. Carmichael Outreach The clean, empty food containers to support the food security program dropped off by members of the congregation are taken over to Carmichael weekly, as well as the food and clothing donated on Carmichael Sunday the fifth Sunday of a month.
- Inter-denomination Sunday Lunch Auxiliary (ISLA) Two Sundays a year sandwiches provided by the congregation are taken to Salvation Army Waterston Centre on Osler Street. Waterston Centre provides support to men who are facing various challenges in life, including but not limited to homelessness issues, mental health struggles, troubles with the law, developing living skills and more.
- 3. Community-4-Connection In November Four Directions Health Centre sponsors a one-day health fair at KMUC to provide health and social services information to folks from the downtown community.
- Lumsden Beach Camp KMUC offers support for two children to attend Lumsden Beach Camp (LBC). LBC is a United Church camping ministry fostering relationships, leadership, environmental stewardship and a connection to nature in a safe, inclusive and sustainable community.
- 5. Regina Homelessness. KMUC provides a hamper of household utensils and items to help homeless individuals transition into their own living space (new apartment).

Outreach provides support for various activities to build positive connections with the community:

- 1. Organized the lunch for the Book Sale in the spring and the Flea Market in the fall.
- 2. Organized Rhubarb Days in June.
- 3. Provide support to ensure all in the community who wish can attend the Knox-Met Christmas meal in November.
- 4. Co-ordinated the work on the Peace Garden on the south side of the church.
- 5. Participate in RIIS cemetery project and TRC 82 (call to action) planning.
- 6. Participate in activities with Kairos Regina.

Both Explorers and Sprouts used materials from "Illustrated Children's Ministry" which engage storytelling and artistic expression in a dramatic and mixed media curriculum.

Junior Leaders continue to hone skills in working with younger children offering much needed support to those teaching lessons and lots of fun for the little worshippers.

Adults in the church were invited to share favourite storybooks with the Spouts class which was a lovely opportunity for intergenerational connection.

Teen Nights continued offering monthly fun and community for youth grade 5 and up! Big highlights this year included a Murder Mystery and Escape Room.

While our family was away, Paula Ricci took over administration of the Teen night and Eilis took lead on Sunday morning programing with support from Rev. Jan, Cecilia Prokop, and Vicki Nelson.

The Church and the CGIT continue to develop a more seamless relationship. The CGIT group hosted a movie night in April 2019 and then held a great end of year celebration with Carol Schick and Cam Fraser attending on behalf of the Church. The CGIT were involved in a Service in the fall, and planned and delivered a fabulous Vesper Service in December.

## **Refugee Committee**

The committee met 10 times during the year. Members of the committee attended other related meetings and training sessions of organizations such as Regina Region Local Immigration Partnership (RRLIP) and New Canadians Integration Society (NCIS). Ralph Paragg from the Refugee Committee of the Anglican Diocese of Qu'Appelle attended our meeting in March.

A major portion of the work this year has been introducing the financial control system required by the federal government. A Memorandum of Understanding is signed with each co-sponsor and standard amounts of money are required in advance trust accounts for each sponsorship request. Money not required for the first year of settlement in Regina will be returned to the cosponsors.

We only interviewed three individuals for cosponsoring relative as we had a backlog of requests from the previous year. We made a request for 4 cosponsorships in June but these were not approved by the Board of Knox-Met as they were not adequately funded. Adequate funds have since been received and cosponsorships will be requested again next year.

Thanks to Dessie Gebreyesus for taking on this work.

We received a filing cabinet from the SaskTel Pioneers that holds the refugee files. Donna Nelson has summarized these records and has created Excel files of the financial records and trust accounts. Rehab Mesfin and Ayoub Mahery arrived in Regina on December 27, 2018. They were linked to the Legesse family request that we have been working on since 2010. The Legesse family accepted financial responsibility for their settlement needs.

Haymanot Ahmed Mohamed, her husband, and 2 children arrived from Kenya on Oct 16 co-sponsored by the Virgin Mary Ethiopian Orthodox Church. They have settled into an apartment near the General Hospital and Asnake Fikadu Argaw, the husband, is working in construction. Shortly after, on Oct 31,

Amanuel Abraha's nephew arrived from Sudan and is studying English.

The committee has met with Andebrhan Redie Hagos, (Andy), a refugee from Eritrea, who regularly attends our church. His wife and 5 children are still in Eritrea. This is a complex case and we are exploring possible ways to help reunite the family.

We would like to thank the Outreach and Social Action Ministry for their fundraising assistance and to the individuals who donate to the Refugee Fund.

## **Book and Music Sale**

Our Book and Music Sale was held on Friday, April 26 and Saturday, April 27, 2019.

Donations of books and music increased by about 30% over 2018. So we decided to get a head start by moving the books out of the storage room down to the Lower Hall on Tuesday afternoon, a day earlier. We felt somewhat overwhelmed when we looked at the huge pile of books. But Vern McCarthy gave us perspective when he said "remember, it's just one box at a time"

Those words came back to us many times over the next few days as our group of hard-working volunteers unpacked and sorted the books. We tried not to panic mid-afternoon on Thursday when there were still boxes unpacked and huge piles of unsorted books on the tables. But we kept at it, and everything fell into place on Friday morning when the Lower Hall was filled with tables of neatly arranged books.

This was just in time for the opening of the sale at 12 noon, an hour earlier than usual. We had a big crowd of eager shoppers, and we had to open a second cash desk to accommodate the long lineups of people. After the initial rush, we had a steady stream of shoppers throughout Friday and Saturday.

At 3:30 PM Saturday afternoon we ended the sale by offering our \$5 "fill a bag with books" special and much frantic shopping ensued. We had to shoo people out of the hall at 4 PM so that we could start our takedown.

We packed up many boxes of soft covered fiction books for "the judges", Chief Justice Bob Richards and Justice Michael Tochor. They loaded the books into their vans and drove them right out to the provincial jail. Many other books were distributed to thrift shops and social agencies throughout the city. The remaining books were taken to the recycle bins. We did our best to keep this as low as possible.

Throughout the days of preparation, sale and take down, we had excellent support from volunteers, from both inside and outside the church. The number of outside volunteers continues to grow, and many of them return year after year to help out.

In the end all of our hard work paid off. We raised \$12,230, up almost \$3000 from the year before.

The bake sale table brought in \$360 and the Outreach ministry realized \$615 from their lunch which goes to the Refugee Fund.

Thank you to all those who work so hard. Special thanks to Kate Johnson for being co-coordinator, to Ev Mazurkie for overseeing the fiction room, to Phyllis Perkins and her crew for the bake sale table, to

the Outreach ministry for the lunch, to Hart Godden for organizing the cleanup crew and to Stewart and Gilda Graham for handling the cash. Special thanks also to Aaron Balkeran, our caretaker, for handling hundreds of boxes of heavy books in the weeks and months before the sale.

### Flea Market

Members of the Ministry of Outreach and Social Justice provided a tasty lunch in the upstairs gym, with proceeds from this lunch going to the Refugee Fund.

The Flea Market is a very big undertaking and an important event in the life of Knox- Metropolitan. It could not happen without the efforts of so many people and the generosity of the community who made donations

## Living Skies Regional Council Inaugural Annual Meeting – Together on a Journey

Swift Current, SK May 30<sup>th</sup> to June 2<sup>nd</sup> Submitted by: Don Henricksen

Attending as representatives of Knox-Metropolitan Church, Regina, SK were: Don Henricksen, Colette Forbes, and Mari-Anne Berriault.

The meeting began with singing, enabling motions, treaty land acknowledgement and worship. We voted, and officially have the name of: "Living Skies Regional Council."

The agenda and docket for this meeting outlined the business, activities, reports & proposals for motions that were "listened to, discussed and decided upon".

Proposals brought forward for voting and acceptance:

- Proposals 1 through 4, were carried with little discussion. These proposals focused on the need to continue developing a brief from the church to the government, the need to hire a mission staff personnel and a refugee liaison for the Region, as well as recommending the Region's continued connection to the Saskatchewan Council for International Cooperation.
- **Proposal 5**, which focused on autobody shops in rural Saskatchewan was withdrawn.
- Proposal 6, concerning voicing our support for the restoration of diplomatic relations between Canada and the Democratic People's Republic of Korea, was carried after a discussion about first consulting with the National Council of Churches of Korea.
- **Proposal 7**, after some clarification, concerning the access to sacraments in rural communities was withdrawn.
- Proposal 8, The Affirming Ministries, was carried and The Living Skies Regional Council will now be going through the process of becoming an Affirming Ministry within the United Church of Canada.
- Proposal 9, regarding Funding for Outreach Ministries of Living Skies Regional Council 1) That Living Skies Regional Council affirm the importance of Outreach Ministries, Camps and Chaplaincies: and that in order to assist in funding these ministries through regional council grants the Regional Council assess Communities of Faith.2) That the Living Skies Regional Council assessment of Communities of Faith for 2020 and 2021 be 20% of the denominational assessment. 3) That the executive will provide bridge funding up to \$100,000 in 2019 based on priorities and need as determined by the Grants Committee.

On Saturday we saw the appointments by acclamation of Tricia Gerhard (Regina, Sunset United) as Regional Council Chair and Rob Reed as Convenor of the Gathering for the 2020 Regional Gathering.

Mari-Anne attended sessions on youth in the Living Skies Regional Council as well as a discussion about camps. Both discussion were well attended and full of insightful and informative conversations the roles members saw youths and camps playing in the Region.

Colette attended workshops that expanded upon the matters facing Indigenous communities of Faith and another discussed the model of The Regina and Area Cluster as a way of bridging relationships between rural and urban communities.

Don attended 2 different workshops. One was on Stewardship Buzz. He learned that Stewardship is about all sorts of giving and the steps involved are: 1) Inspire, 2) Invite, 3) Thank. The second workshop was on Support for Ministry Personnel. He learned that these people do SO MUCH MORE that they learned in their training! THANK YOU EACH AND EVERY ONE!

It was especially touching to hear stories of ministries being celebrated both with retirements and memorials of those in ministry as well as those entering ministry.

The food was excellent!

## **Clare Parker Homes Inc. 2019 Annual Report to Congregations** Rosa Smith, Executive Director



Clare Parker Homes (CPH) has had a busy year. CPH opened its many new programs in 2019. In March of 2019, Green Water Home was opened. In October 2019, Green Brook Home opened. In September 2019, the Garritty rebuilding project came to completion. In September 2019, A supported independent living suite was built under Garritty. Over this past year, CPH has transitioned 12 people into residential services as well as 12 people into day program services.

The Green Water home supports 4 women that transitioned from Valley View Centre to the Regina community. The Green Brook home supports 4 men that transitioned from Valley View Centre to the Regina community. Although, the home officially opened in October, we have been supporting these men since April 2019.

Along with this CPH has expanded the Community Inclusion Program (quality of life day program) to support all of our CPH homes. This expansion has allowed for CPH to partner with Prairie Valley School Division to run a you summer employment pilot project. This project will be running again in summer of 2020.

Community Inclusion supports 24 people in various opportunities. 5 people have gained paid employment through Community Inclusion and the Supported Employment Transitions Initiative (SETI) grant at Harbour Landing Village, Tom's Independent Grocers and ReStore. Some of the people we serve spend time volunteering at REACH (Regina Education & Action on Child Hunger), and as a result we have been able to establish a valued place for these volunteers.

Early in 2017, the agency began working with the Ministry of Social Services to develop a replacement plan for one of our older homes in which 5 people reside. This project has been completed. With the new build, CPH was able to build a living suite under the main floor. This suite is used to support 1 individual in a supported independent living situation.

CPH continues to strengthen the focus on person-centred care in order to increase quality of life for the people that we serve and develop a greater community presence.

The broad mix of professional, church, family and community board members ensure that all aspects of issues are considered, with spirited discussion lending itself to sound decision making.

Through partnerships with Saskatchewan Polytechnic, Chip & Dale Homes and Citizen's All (Moose Jaw) we continue to be able to bring the Disability Support Worker Certificate program to Regina to better educate our employees. Over 2019, the agency received educational funding assistance through the Saskatchewan Canada Job Grant. With this funding, CPH invested in a 9-session leadership training offered through SARC (Saskatchewan Association of Rehabilitation Centers). The agency has partnered with Bed, Bath and Beyond and the Good 360 program in order to receive donations for Household items regularly.

With the growth CPH has seen since 2016, our agency staffing compliment has increased from 44 employees (2015) to 112 employees. Upon reflection, we continue to be blessed by all the staff, volunteer, and family commitment in support of our agency. We look forward to continued enhancements and improvements during 2020.
